## Nearly \$3 Million Awarded in the San Joaquin Valley

Funding provided to 69 organizations working on policy and systems change to improve health

**Sacramento and Merced** – Today, The Center announced nearly \$3 million awarded to 69 organizations working on policy and systems change to improve health outcomes in the San Joaquin Valley. These San Joaquin Valley Health Fund (the Fund) partners are working in one or more of the nine counties of Fresno, Kern, Kings, Madera, Mariposa, Merced, San Joaquin, Stanislaus and Tulare that comprise the Valley. This third round of funding includes 54 individual grants and four cluster grants, a grant category added for the first time, supported by 16 organizations. Individual grants will fund organizations working to address health disparities and factors that impact health, such as food security, air quality, clean drinking water, housing, health care, education, employment, immigrant rights, domestic violence, open space, neighborhood safety and other drivers of health outcomes.

Awarded cluster grants will complement the individual grant program by connecting groups of nonprofit partners committed to accelerating policy and systems changes to improve the health and well-being of vulnerable children and advance racial and health equity. Data in a report commissioned by the Fund and released last month, *California's San Joaquin Valley: A Region and Its Children Under Stress*, shows eight of the San Joaquin Valley counties are among the top nine agricultural producers in the state, and seven of these same counties are in the top 10 counties with the highest child poverty rates. Additionally, given that one out of every four Valley children experiences food insecurity and they are much more likely to be exposed to pesticides, cluster grants will focus on protecting children from pesticides and immigrant communities with running themes of environmental justice and community mobilization.

Building off Equity on the Mall in February when more than 1,000 San Joaquin Valley residents rallied at the State Capitol to highlight what is needed for a "golden state for all," the funded organizations met today to discuss the intersection of their work to build community mobilization. Participants heard from City of Stockton Mayor Michael Tubbs as well as philanthropic leaders.

"We choose to fight, we choose to organize, we choose to make sure the Valley is just as golden as the rest of the state," said Mayor Michael Tubbs, City of Stockton. "California cannot be great until the Valley is as fertile as the land that produces the fruits and vegetables the state enjoys."

"The unfolding story is more about the promise of a California dream fulfilled than about the challenges the region has to overcome," said Chet P. Hewitt, President and CEO, The Center. "The region's leaders understand that a healthy and prosperous California requires a healthier and more prosperous Valley, and are committed to doing all that it will take to ensure the dream of an inclusive and equitable California is realized."

Established in 2014, The Fund is a partnership of 69 nonprofit organizations, along with nine state and national foundations, who are jointly working to build a greater level of health equity in this important part of the state. The Fund is managed by The Center with funding from Sierra Health Foundation, The California Endowment, Rosenberg Foundation, The California Wellness Foundation, W.K. Kellogg Foundation, Blue Shield of

California Foundation, Wallace H. Coulter Foundation, Dignity Health and Tides Foundation. With the announcement of this funding, the Fund has made more than \$4.7 million in grant commitments to support these community organizations.
