#### **Steering Committee Goals for BCLC**

Jedida Gomes, BCLC Program Officer

- I. Data from 2020
- II. Goal: Child Abuse and Neglect Homicides deaths decrease by 25%
  - a. Goal exceeded: 88% decrease
- III. Goal: Opportunities and positive experiences provided to youth resulting in a 48% reduction of 3<sup>rd</sup> party homicides
  - a. Goal in process: 22% decrease
- IV. Goal: Child deaths due to perinatal conditions decrease by at least 23%
  - a. Goal in process: 4% decrease
- V. Goal: Child deaths due to infant-safe sleep decrease by at least 33%
  - a. Goal exceeded: 54% decrease
- VI. Linda Fong-Somera, RAACD Steering Committee
  - a. Maybe Steering Committee should set goals through 2030
    - i. Encourages idea that this should be a continued supported effort
    - ii. Also in-line with other community work (i.e. Healthy People)
    - iii. First 5 is currently working on 2023 data
