Chairwoman, Shingle Springs Band of Miwok Indians
Regina Cuellar is Chairwoman of the Shingle Springs Band of Miwok Indians and a
longtime leader in Tribal governance. Under her leadership, the Tribe has expanded its
land base, built a hotel and entertainment center, and launched culturally responsive
family services. She was instrumental in establishing the Feather Alert system for
Missing and Murdered Indigenous People and serves on both the California
Commission on the State of Hate and the Greater Sacramento Economic Council.



## **Shelly Covert**

Spokesperson, Nevada City Rancheria Nisenan Tribe
Shelly Covert is the Spokesperson for the Nevada City Rancheria Nisenan Tribe and
Executive Director of CHIRP, a nonprofit dedicated to preserving Nisenan culture. She
leads outreach and education efforts to uplift the Tribe's history and supports the
community's fight to restore federal recognition. Shelly's work emphasizes truthtelling, cultural preservation, and advocacy for social, environmental, and racial justice.



## Reyna Villalobos

Managing Director, Regional Programs, The Center at Sierra Health Foundation
